## Meet Morton Grove Historical Society

Our January 2008 Member of the Month

The Morton Grove Historical Society began under the direction of a Village senior citizens' organization in the early 70's. The Society

became an official not-for-profit 501(c)(3) in 1976 in celebration of our nation's Bi-centennial. The Society has been cooperating with many organizations in our community towards the preservation and protection of

historical structures and landscapes since its inception. The designation and interpretation of historic sites are marked by bronze plaques throughout our village, and the Society continues to search out, collect, and preserve materials and objects that reflect Morton Grove's unique heritage to this day.

In the early days, the Society stored its collection in the lower level of the Village Hall. As their collection grew, it became apparent to the group that a larger facility was necessary to house this priceless collection for future generations. Through the efforts of local fundraisers and generous donations from local businesses and private citizens, \$50,000 was raised to move and refurbish Dorothy Yehl's House on Lincoln Avenue. The Haupt-Yehl House was built in 1888 by Dorothy's grandfather, Nicholas Haupt, and represents a typical farmhouse from the turnof-the-century in Morton Grove. The Society purchased this house for the sum of one dollar, with the stipulation that the house be moved to a new location. The Morton Grove building in Harrer Park. Through the diligence of the Society's members and the cooperation of the Park District, the Haupt-Yehl House was

successfully moved to its new location in 1984 and dedicated as the Morton Grove Historical Museum in 1986.

The Morton Grove Historical Society, in cooperation with the

Morton Grove Park District, also provides related educational services for the purpose of increasing and enriching public knowledge about the Village of Morton Grove to the community and dozens of local schools. To continue to meet the needs of our growing and changing community, the Society and the Park District have once again embarked on an exciting new project - an Education Center Annex. This 1,400 square foot archival storage and classroom facility, which will benefit our entire community, is under construction just east of the historic 1888 farmhouse on land contributed by the Village of Morton Grove. \$110,000 in charitable contributions for the completion of this \$520,000 capital project is still necessary to bring this project to fruition. Community service has also been an important part of Gabe's career. He served as a Director for two terms of the Morton Grove Chamber of Commerce and Industry and was a charter member and a State Director of the

Morton Grove Jaycees. He's also served on the Board of Directors of the Action Party of the Village of Morton Grove and has been a member of the American Legion Post 134 for over 40 years.

Gabe recently lost his beloved wife lrene after 55 years of marriage. He is devoted to his 7 children and 10 grandchildren. He enjoys playing golf, especially at the Ridgemoor Country Club, where he served as Club President from 2002 through

On January 1, 2008, all public places and places of employment in Illinois-including bars, taverns, casinos, and restaurants will be required to go smoke free, protecting employees and the general public from the danger of secondhand smoke. Smoking will be prohibited in a public place or place of employment or within 15 feet of

an entrance to a public place. "No Smoking" signs or the international "No Smoking" symbol must be clearly and conspicuously posted in each public place and place of employment where smoking is prohibited and all public ashtrays must be removed. The following locations are exempt from the Smoke Free Illinois Act.

- Private Residences (except when used as a business, childcare, adult care or health care facility)
- Private Vehicles
- 25% of hotel/motel rooms may be permanently designated as smoking rooms
- Retail Tobacco Stores (may not serve food or drink and must derive 80% of gross receipts from the sale of tobacco products)
- Private/Semi-private rooms in nursing homes or long term care facilities

The Illinois Department of Public Health (IDPH) is the lead state agency responsible for enforcement, however, local health departments and local law enforcement are also able to write citations.
